Filing Deadlines: Please note that EDGAR Forms 3, 4 & 5 have a filing deadline of 10:00 p.m. EST, whereas all other EDGAR forms have a filing deadline of 5:30 p.m. to receive same-day acceptance date.

Definitions:

“Page” refers to standard letter or legal sized portrait pages.

“Tabular Page” is any page with a financial table or text arranged in tabular form that fills 50% or more of the page.

“Word Processing” refers to files originally in Microsoft Word & Excel, Word Perfect, etc. and PDF files created from word processing/spreadsheet programs.

“Desktop Publishing” refers to files from Quark, PageMaker, FrameMaker, and any other desktop publishing or typesetting system as well as PDF files created from desktop publishing or typesetting systems.

Exceptions to these prices may be made upon review of the copy and files to be converted and will be made at the client’s approval. Examples: typeset pages containing complex formats; small-type leases and other similar contracts; very wide landscape tables.

Business hours: 9 a.m. to 6 p.m. Monday through Friday (except holidays); open later during peak filing periods.
